Introduction

The Global Timber Tracking Network (GTTN) Regional Workshop for Asia will be organised back-to-back with the IAWA-IUFRO international symposium on "Challenges and Opportunities for Updating Wood Identification", in Beijing, China. This is through cooperation with the Chinese Research Institute of Wood Industry of the Chinese Academy of Forestry (CAF) and the International Association of Wood Anatomists (IAWA). The IAWA-IUFRO symposium will take place on 20-22 May and the GTTN-IAWA workshop will be on 22-23 May.

The GTTN Asia Regional Workshop will address key issues related to the successful development of timber tracking tools and policies, and promote their use to reduce illegal logging and associated trade worldwide. The IAWA-IUFRO symposium will address wood identification methods development in detail, while the GTTN Asia Regional Workshop will look at demand and possible barriers for timber tracking in Asia. With many on-going activities represented, we will also look to be inspired as to how frameworks for cooperation might be further developed. On the second day we will have facilitated discussions on topics ranging from strengthened regional to global cooperation between institutions on sampling, reference data and lab capacities, to more specialized topics of methods selection guidance, tree species prioritization and communications. By addressing practical questions, we will seek to develop milestones for possible joint future activities.

Under this topic we map what wood identification capacities exist in Asia, how timber tracking could be integrated in chain-of-custody systems, what joint interests exist between different stakeholder groups and how successful coalitions could be forged to strengthen timber tracking cooperation both within, but also between Asian countries.

- **Topic 1B. The Timber Tracking Tool Infogram - discussing the way forward** (facilitated by dr. Nele Schmitz)

In April the GTTN published its timber tracking tool infogram, giving an overview of the capacities of the different wood identification methods. During this workshop we will discuss (i) how this infogram can be further improved for a second edition, (ii) the opportunities and threats this overview reveals for further timber tracking developments and implementation, and how we can act to grab these chances and avoid or mitigate the risks.

- Topic **2C**. The potential hindrance of language in timber tracking tool development

With the GTTN being a global network, a multitude of languages is being used for information sharing between timber tracking experts. In this workshop we want to evaluate in how far this diversity of languages is a hindrance to timber tracking tool development, and how we can take action.
